**OBJECTIONS OF THE COMPLAINT TO THE 'B'
REPORT SUBMITTED IN THIS CASE IS AS FOLLOWS:-**

1. The Complainant by name Bhaskaraiah S/o Subba Naidu, R/at Motluru Village, Nandi Hobli, Chickballapur Taluk and District has instituted this case against the accused persons for the offence punishable under sections 143, 147, 323, 324, 427, 447, 504, 506, 149 of IPC.
2. As per the complaint the Rural police Chickballapur registered the FIR against the accused persons and finally submitted the 'B' report.
3. One Nagaraja S/o Hanumanthappa, Sri. Venkatesh S/o Singalappa and Sri. Gangappa S/o Doddamallappa were the eye witnesses to the incident who were present on 22/04/2023. They pacified the Galata and they prevented the complainant from the hands of the accused persons. In fact on 22/04/2023 at around 1-00 PM, the accused persons were unlawful assembled with common object and wrongfully restrained the complainant with peaceful enjoyment of the his property. The complainant is running Goshala in the complainant's property and to shelter for homeless or unwanted cattle that often also serves as a

center for bread improvement and for study of bovine nutrition and welfare. The accused persons were taking tractors with them and illegally broken the pitched stones slabs fixed to the compound wall around the complainant's property and further they are also trying to cultivating to complainant's property illegally and put the quarrel against complainant and the complainant questioned the same to accused persons, why you are unnecessarily interfere with Goshala(Cowshed) and the accused persons abused filthy languages and insult the complainant and the accused persons beaten and kicked the complainant with sticks and abused life threat to complainant

4. The I.O. has not interrogated the witnesses and also not enquired the eye witnesses. The accused persons are very powerful and rich, they instigated the I.O. to file 'B' report by furnishing false statement of the witnesses. The statements furnished by the I.O is purely created one. There is no signatures of the witnesses on the statements.

5. The witnesses cited above will appear before this Hon'ble court to file affidavit disclosing the real facts by the leave of this Hon'ble court.

6. The I.O. by sitting in his office has drawn the statement as per his own whims. When the I.O has not interrogated the witnesses, the question of filing their statement in the case does not arise. The statements are created one.

7. The I.O has defamed the complainant in the 'B' report by suggesting the false re-statements. It is further defamed

in the 'B' report by saying that, the complainant has filed false this complaint against accused. The allegations made in the 'B' report against complainant are false and untenable.

8. The complainant will be put to immense hardship and trouble if the 'B' report is accepted.

9. At the time of lodging the complaint itself, the complainant has mobile recordings regarding to Galata and if required, the complainant is ready to submit the before this Hon'ble court, as per the law, at the time of evidence. But the investigation officer has not enquired the same and collected as per the law by the complainant.

10. If the 'B' report is not rejected by the Hon'ble court, the complainant will be put to immense hardship and injury, per contra the accused will not be put to any injustice if the 'B' report is rejected. The complainant is very poor. If further investigation is not made, there is every chances of repeating the same incidents in the locality by the culprits.

Wherefore, it is respectfully prayed that this Hon'ble court be pleased to reject 'B' report and register this case against the accused persons and punish them in accordance with law as prayed for in the complaint.
